Sub: Evaluation of Answer Script and payment of remuneration for +3 3rd Semester Back Examination, 2020 (2016, 2017 & 2018 Admission Batch) – regarding.

Madam/Sir,

It is for information of all the Principals that the +3 3rd Semester Back Examinations, 2020 (2016, 2017 & 2018 Admission Batch) will be started from 06.04.2021. Due to shortage of time and immediate publication of results, the answer scripts will be evaluated as per the following guidelines.

- 1. The evaluation of answer script for the above examination will be done in their own colleges/institutions under the direct supervision of the Principals.
- 2. There is no provision for Zone Officer / Zone Supervisor / Zone Assistant etc. as all the colleges are now considered valuation zones.
- 3. Only registered teachers having teacher code will examine the answer script.
- 4. The teachers from Self Financing Colleges are not permitted to value the answer scripts. They are requested to invite the teachers from nearby regular affiliated colleges (those who have registered teachers codes) and get the answer scripts examined with provision of CA to examiner.
- 5. After valuation, the theory marks be uploaded in our UUeMS portal as per the mark foil uploaded following same procedure.
- 6. All the Principals are requested to complete the valuation work and upload all the marks in the UUeMS portal within four (04) days of completion of examinations. For those candidates who have secured 60% and more percentage of marks in any paper, their answer scripts along with printed mark foils be submitted to the Examination Confidential Unit-II, Utkal University for further examination by a Chief Examiner at this end.
- 7. The remuneration for evaluation of answer script may be paid @ Rs.30/- per script.
- 8. The remuneration for officials like Office Assistant / DEO / Class-IV / Contingency etc may be met as per our earlier Notification No.EC-III/002/96/2020, dated 11.09.2020.
- 9. TA / DA / CA are not allowed for this valuation work for valuation in the own college/institution.
- 10. All the Principals are requested to pay the above remuneration from the existing available balance amount (year together) of "Centre Charge" collected @ Rs.100/- from the students at the time of form fill up. Shortage of fund, if any, after payment from previous years collection may be brought to the notice of the undersigned for necessary course of action at this end.
- 11. The paid vouchers may be kept in the college for audit purposes.

All the Principals are requested to follow the above guidelines strictly during the valuation.
